It is now possible to access your organisations' Daily Data Lake Files, directly from the Comaea platform. It is no longer necessary for you to login to your SFTP site or have the files sent to you – you can access them daily, weekly, monthly, or ad-hoc to suit your requirements.

The files are .csv formatted, and customers generally convert them to Excel, for onward data management, or import to PowerBi or similar – therefore we will be presenting them in Excel format instead soon.

Access to the Data Lake Files is Permission Driven, and you will decide and set who has access and permission to your Comaea data – which contains assessment and employee data.

Comaea can support you with assigning the DLF Export permissions*, however each Organisation will be responsible for those who are granted access to the data.
